- draped reins (per maneuver) - break of gait at walk or trot for 2 strides or less to 4 steps on mount/dismount or ground tie
- space at a walk or trot
- skipping over or failing to step into required apaging out of or falling off an obstacle with 1 foot missing or evading a part of log/obstacle with 1 foot
- split pole in lope-over
- incorrect number of strides, if specified
- 1 to 2 steps on mount/dismount or ground tie spurring in front of cinch except shifting to balance
- wrong lead or out of lead for 2 strides or less use of either hand to instill fear

5 points

- blatant disobedience (kick, bite, buck, rear, etc.) for each refusalameness
